President Anderson led everyone in the Pledge of Allegiance.

A motion was made by Kinkade and seconded by Dougherty to approve the minutes of the July 8, 2013 regular Village Board meeting. Roll call was as follows: Dougherty-aye; Curtisaye; Irvin-aye; Kinkade-aye; Kester-aye. Motion carried, 5-0.

The bills were presented for payment from the various funds in the amount of \$25,359.65. A motion was made by Curtis and seconded by Kinkade to pay the bills as submitted. Roll call was as follows: Dougherty-aye; Curtis-aye; Irvin-aye; Kinkade-aye; Kester-aye. Motion carried, 5-0.

A motion was made by Kinkade and seconded by Irvin to approve the June 2013 Treasurer's report as submitted by Village Treasurer Diane Jensen showing a balance in all funds of 2,321,528.23. In Public Forum, Tom Tock, 410 W. Delaware St., inquired if the Village was taking any action against Spud Inc. due to the default on their loan. The Village filed a lien, but Attorney Neville indicated that the bankruptcy filed by Spuds Inc. stops all creditors from collecting at this point.

Tock also asked whether the Village has the money for our portion of the Pinecone Path grant and the Depot grant. Administrator McNamara responded that Phase I of Pinecone Path is done, and that the Village has eight (8) years to complete that project. In the case of the Depot, the Village has three (3) years to complete.

Tom Ivey, 222 E. North St., complained about a hole on Northbrook Dr. President Anderson said he talked to Dan Anderson of Anderson Concrete about it.

John Moyemont, 200 W. Waupansie St., and owner of J. T.'s Saloon, 118 E. Main St., and MAW Acres, 111 E. Chippewa St., said he would like to buy the Village property next door to his business on E. Chippewa St. to start a flea market. Moyemont also asked about having a beer garden during Harvest Days either in front of J.T.'s on E. Main St. or next to the 111 E. Chippewa St. property. He will have to submit a Special Use Liquor License application for that request.

President Anderson reported on the following:
