FINANCIAL REPORTS

Payment of the November 27, 2017 bills in the amount of \$106,343.25 were presented for payment from the various funds. Trustee Kinkade made a motion, with a second from Trustee Johnson to pay the bills as submitted. Roll call. All voted aye. Motion carries.

The following fund transfer were requested by Finance Director Austin Haacke:

\$402,832.50 from Referendum fund (36) to Referendum Bond Fund (47) to pay interest and principle on bond. Trustee Mixen made a motion with a second from Trustee Kinkade to approve the fund transfer as presented by Finance Director Austin Haacke. Roll call. All voted aye. Motion carries.

\$85,250.00 from the Water Fund (51) to the Water Bond Fund (41) to pay interest and principle on bond. Trustee Mixen made a motion with a second from Trustee Kinkade to approve the fund transfer as presented by Finance Director Austin Haacke. Roll call. All voted aye. Motion carries.

\$200,000.00 from the Water Capital Fund (32) to the Water Bond Fund (41) to pay interest and principle on bond. Trustee Kinkade made a motion with a second from Trustee Johnson to approve the fund transfer as presented by Finance Director Austin Haacke. Roll call. All voted aye. Motion carries.

\$51,714.93 from the Sewer Fund (52) to the Sewer Replacement Reserve Fund (33) to pay interest and principle on IEPA loan. Trustee Mixen made a motion with a second from Trustee Kinkade to approve the fund transfer as presented by Finance Director Austin Haacke. Roll call. All voted aye. Motion carries.

PUBLIC FORUM

Tom Tock inquired on Republic Services picking up leaves, asking their cost verses the Village workers picking them up. He was informed that Republic does this as a part of their contract four times per year.

VILLAGE REPORTS

Trustee Eggenberger gave the president's report informing the board on the upcoming dates and events for the holiday season. The Christmas parade will be held December 1, 2017 at 6:00pm, Breakfast with Santa on December 2, 2017 and then Christmas Under the Windmill at the Country Mansion on December 3, 2017.

Deb Karch from the Dwight Economic Alliance reported on design for the Village portfolio. These will be used to give out information on the Village to new residents, community members and small businesses. She also attended a meeting in Morris with Bill Flott about solar energy. This meeting was an overview of what potential is in solar energy and the state mandates with renewable energy. Finally, she gave a report on the CBRE report score model they use in evaluating sites and locations. These scores are based on the real estate, business climate, location access, economic considerations, and other factors.

ORDINANCES/RESOLUTIONS

The State of Illinois will celebrate its 199th birthday on December 3, 2017. This day will kick off a year-long statewide celebration leading up to Illinois Bicentennial on December 3, 2018. Dwight and other towns across the state will celebrate the kick off on Monday, December 3, 2017 with a special flag raising. Village Administrator, Kevin McNamara, presented the new numbers for the 2018 Illinois Municipal Insurance Cooperative Renewal. The Village premium rate at 85% funding is \$117,212.00; \$2,600.00 less than the current year Last year, cyber liability was an option which the Village purchased, and this year cyber liability is included in the package. The Co-op is also for the first time partnering with the Illinois Public Risk Fund to add Workers' Compensation coverage to the IMIC program. Trustee Kinkade made a motion with a second from Trustee Mixen to approve the Illinois Municipal Insurance Cooperative Renewal for the 2018 year. Roll call. All voted aye. Motion carries.
