President Anderson called the meeting to order at 6:47PM and led the Pledge of Allegiance.

President Anderson presented the Treasurer's report for February 2020. Trustee Eggenberger made a motion with a second from Trustee Butterbrodt to approve the February 2020 report as presented. Roll call. All voted aye. Motion carries.

President Anderson presented the following fund transfers for approval.

They have also been directed to daily keep the Amtrak station clean and sanitized.

Tim Henson informed the board he is communicating with his officers daily. They have doubled up on the night shift. He is also making sure to keep an eye out on all the business that are closed because of the shutdown.

Kevin LeRoy form EMS reported that all employees are healthy and checking temperatures of the staff at the start and end of each shift. All IDPH inspections have ceased to get the new ambulance but through Morris Hospital we may be able to self-inspect with IDPH approval.
