Trustee Irvin made a motion with a second from Trustee Eggenberger to approve the fund transfer of \$125,807.57 from General Fund (01) to the Referendum Bond Fund (47). Roll call. All voted aye. Motion carries.

Trustee Curtis made a motion with a second from Trustee Johnson to approve the fund transfer of \$301,950.00 from Water Fund (51) to the Water Bond Fund (41). Roll call. All voted aye. Motion carries.

Trustee Kinkade made a motion with a second from Trustee Butterbrodt to approve the fund transfer of \$51,714.93 from Sewer Fund (52) to the Sewer Replacement Reserve Fund (33). Roll call. All voted aye. Motion carries.

Trustee Irvin made a motion with a second from Trustee Kinkade to approve the fund transfer of \$17,694.00 from General Fund (01) to the Capital Expenditure Fund (38). Roll call. All voted aye. Motion carries.

NEW BUSINESS

Mayor Anderson has been in contact with IDNR about decreasing the goose population at Lions Lake. It is recommended the Village close Lions Lake to the public on the first three weekends of December to allow for hunting. Trustee Irvin made a motion with a second from Trustee Kinkade to approve the closure of Lions Lake on Saturday and Sunday for the first two weekends in December, December 5-6 and December 12-13; and closed Friday to Sunday the third weekend in December, December 18-20; for goose hunting. Roll call. All voted aye. Motion carries.

Gene Mortenson with the Salvation Army is requesting a donation from the Village for the organization. With the lack of revenue coming into the Village, the board decided not to donate at this time.

Finding no further business, President Anderson asked for a motion to adjourn. A motion to adjourn was made by Trustee Curtis with a second by Trustee Eggenberger. Roll call. All voted aye. Motion carries. The meeting adjourned at 7:01PM.
